RESOLUTION OF THE BOARD OF SUPERVISORS
ORDERING FORMATION OF THE
JACUMBA COMMUNITY SERVICES DISTRICT

On MOTION of Supervisor <u>Bailey</u>, seconded by Supervisor <u>Eckert</u>, the following resolution is adopted:

WHEREAS, pursuant to the Community Services District Law, commencing with Section 61000 of the Government Code, preliminary proceedings were commenced by a petition signed by registered voters within the proposed district and application made to the San Diego Local Agency Formation Commission for the formation of a Community Services District; and

WHEREAS, on October 7, 1985 the formation proposed by said petition was presented to and approved by the Local Agency Formation Commission as Resolution DF85-2, and this Board of Supervisors was designated as the conducting authority and directed to initiate formation proceedings pursuant to Section 61100 of the Government Code; and

WHEREAS, on November 6, 1985 this Board of Supervisors adopted its resolution initiating proceedings for formation and setting a hearing on the matter for December 4, 1985; and

WHEREAS, at said hearing on December 4, 1985 this Board of Supervisors was prepared to hear and receive oral and written protests against the formation, any request with respect to modification of its terms and conditions, and any objection evidence which might be made, presented or filed, but none were offered; and

WHEREAS, this Board finds that, pursuant to Government Code Section 61114, 80 percent of the registered voters within the proposed district have signed a petition in favor of the formation; NOW THEREFORE

IT IS FOUND AND DETERMINED as follows:

- 1. The proposal for formation was made by a petition signed by 80% of the registered voters within the proposed district.
- The name of the only special district affected by this proposal is the Jacumba Community Services District, which is proposed to be formed.
- 3. The formation of the territory proposed to be formed and the conditions to be met have been designated by the Local Agency Formation Commission in Resolution DF85-2. The exterior boundaries of the proposed district are described in Exhibit A, attached hereto and incorporated herein.
- 4. The territory within the district proposed to be formed is inhabited.

- The reason for the proposed formation is to take over water service from the existing private water company and provide park and recreation services.
- The new community services district would not be assuming the costs of providing services from an affected local agency, therefore, no exchange of property tax revenue shall be required.

IT IS RESOLVED, FOUND, ORDERED AND DETERMINED as follows:

- The District shall be known as the Jacumba Community Services District.
- 2. This Board of Supervisors finds and determines that the boundaries and terms and conditions as approved by the Local Agency Formation Commission, should not be modified and the District is formed with said boundaries and terms and conditions.
- The Board certifies that it has reviewed and considered the information contained in the Negative Declaration approved by the Local Agency Formation Commission dated September 12, 1985.
- The Board determines that the Jacumba Community Services District is formed without an election, pursuant to Government Code Section 61114.
- 5. The types of services proposed to be provided within the area are water supply and distribution, and park and recreation services.
- The District shall have three members of a separate Board of Directors.
- 7. There being only three nominations to the Board of Directors of this District submitted to the Board, the Board hereby designates without an election these following persons to serve as the independent Board of Directors of this District:
 - (1) Richard W. Fauble
 - (2) Donald M. Shirley
 - (3) William E. Parker

Each designee is a registered voter residing within the boundaries of the proposed District, pursuant to Government Code Section 61200.

8. The Board of Supervisors orders that, pursuant to Elections Code 23506, the Directors first appointed shall classify themselves by lot so that the terms of office of one of them shall be until the election and qualification of successors at the first succeeding general district election, and the terms of office of two of them shall be until the election and qualification of successors in the second succeeding general district election.

The powers which may be exercised by the proposed Jacumba Community Services District are as enumerated in Public Contract Code Section 20681 (a) and (e).

IT IS FURTHER ORDERED that the Clerk of the Board transmit a certified copy of this resolution, to the Executive Officer of the Local Agency Formation Commission. The fees for the State Board of Equalization shall be postponed until such time as the District receives its first revenues pursuant to Section 54902.5 of the Government Code.

All that portion of Sections 7 and 8. Township 18 South, Range 8 Bast, San Bernardino Base and Meridian, in the County of San Diego, State of California, according to United States Government Survey, lying within the following described boundaries:

Beginning at the intersection of the southerly prolongation of the westerly line of Lot 8 in said Section 7 with the international boundary line between the United States of America and Mexico;

- 1. Thence easterly along said international boundary to the southerly prolongation of the easterly line of Lot 8 in said Section 8, said township and range;
- 2. Thence northerly along said southerly prolongation and easterly line to the northeast corner thereof, being also the southwest corner of the northeast quarter of the southwest quarter of said Section 8;
- 3. Thence easterly along the south line of said quarter-quarter to the southeast corner thereof, being also the southwest corner of the northwest quarter of the southeast quarter of said Section 8;
- Thence easterly along the south line of said quarter-quarter to the southeast corner thereof;
- 5. Thence northerly along the east line of said quarter-quarter to the northeast corner thereof;
- 6. Thence westerly along the north line of said quarter-quarter to the northwest corner thereof, being also the southeast corner of Jacumba, according to Map thereof No. 1707, filed in the County Recorder's Office of San Diego County, May 28, 1919;
- 7. Thence North 1°01'30" East, 1331.80 feet and South 89°32' West 1320.30 feet along the east and north boundary of said Map No. 1707 to the northwest corner thereof, being also the southeast corner of the northwest quarter of the northwest quarter of said Section 8;
- 8. Thence northerly along the easterly line of said quarter-quarter to the north line of said Section 8;
