Greetings JCSD Board Members. Hope all is well. Water quality this month was good (samples taken on back sheet). This month Emilio and Preston exercised and cleaned out valves throughout the district. The district sold construction water this month for a few days to contractors working on Old Hwy 80. The solar array at the Filter Plant has been in production for a month and has produced over 5,700 kWh into SDGE power grid this month.
